



**WAIVER OF LIABILITY AND ASSUMPTION OF RISK**

- 1) I, the undersigned, am over 18 years of age, and will be participating in the activities and events offered by Drop in Sports. I am executing this waiver of liability and assumption of risk as a condition of, and in consideration for, my own participation and that of the Participants in the Services provided by Drop in Sports. I understand that engaging the Services of DropInSports.ca may expose me to a variety of risks from activities that are part of the Services. Such risks include, but are not limited to: damage or destruction of my personal property or the personal property of others, injury or death to myself or other Participants.
- 2) By signing below, I hereby:
  - A) ACKNOWLEDGE THAT I FULLY UNDERSTAND THE RISKS OF PARTICIPATING IN DROPINSPORTS' SERVICES, AND THAT SUCH PARTICIPATION IS POTENTIALLY DANGEROUS, AND ASSUME ALL OF THE RISKS (WHETHER OR NOT SPECIFICALLY DESCRIBED HEREIN) ARISING FROM, OR RELATED TO, ANY PARTICIPANTS' PARTICIPATION IN DROPINSPORTS' SERVICES, AND WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF DROP IN SPORTS AND ANY OF THOSE ORGANIZING, PLANNING, SPONSORING, OFFICIATING, OBSERVING OR ASSISTING WITH DROP IN SPORTS' SERVICES OR THEIR RESPECTIVE AGENTS (DROP IN SPORTS' ORGANIZERS"), OTHER PARTICIPANTS, OR OTHERWISE.
  - B) INDEMNIFY, DEFEND AND HOLD HARMLESS DROP IN SPORTS' ORGANIZERS AND EACH OF THEM FROM ANY COSTS AND LIABILITIES OF INJURY, DAMAGE OR DEATH ARISING FROM OR RELATED, DIRECTLY OR INDIRECTLY, TO PARTICIPATION IN DROP IN SPORTS' SERVICES INCLUDING, WITHOUT LIMITATION, ANY PARTICIPANT'S OR THIRD PARTY'S PRESENCE IN THE AREA WHERE DROP IN SPORTS' SERVICES ARE BEING PROVIDED, ANY ACT OR OMISSION ON THE PART OF A PARTICIPANT, AND ANY BREACH OF ANY AGREEMENT OR WARRANTY SET FORTH HEREIN, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF ANY DROP IN SPORTS ORGANIZERS, OTHER PARTICIPANTS OR OTHERWISE.
- 3) I understand that Participants may be photographed. I have been advised and have agreed to allow my/our photo, video or film likeness to be used for any legitimate purpose by Drop in Sports' Organizers.
- 4) I hereby consent, and have received the requisite consent of the other Participants, to receive medical treatment that may be deemed advisable in the event of injury, accident and/or illness during this event.
- 5) I understand and agree that this waiver of liability and assumption of risk shall be governed by and construed in accordance with the laws of the Province of Ontario, and that it is intended to be as broad and inclusive as permitted under such laws. If any portion of it is held to be invalid, I agree that the remaining terms shall continue to be in full legal force and effect.
- 6) **SPORTSMANSHIP AND FAIR PLAY AGREEMENT:** I have read, understood and will abide by the rules of ice skating as outlined by Drop in Sports.

I am aware that by signing below, I am waiving certain legal rights which I or any heirs, next of kin, executors, administrators and assigns may have against Drop in Sports, and its directors, officers, employees, agents and representatives.
